

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Santa Cruz Community Budget Amendment No. 1 Adding Additional
Language to its Donation and Contribution Line Item)

RESOLUTION NO. 11-059

1 **WHEREAS, the Legislative Council reviewed a proposal from Santa Cruz Community to add**
2 **additional language to its FY 2011 budget justification; and**

3 **WHEREAS, the budget justification modification was also reviewed by the Santa Cruz Community**
4 **at a meeting held on January 19, 2011; and**

5 **WHEREAS, the community decided to include additional wording to its Donation and**
6 **Contributions line item to read (Monetary Donation to programs or departments to**
7 **assist in funding various requests on a case by case basis. A one time assistance of**
8 **\$400.00 per household to use towards the purchase of furniture, mattress, and grills).**

9 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the Santa Cruz**
10 **Community Budget Justification Amendment No. 1 for it FY 2011 Budget to read**
11 **Monetary Donation to programs or departments to assist in funding various requests**
12 **on a case by case basis. A one time assistance of \$400.00 per household to use towards**
13 **the purchase of furniture, mattress, and grills.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **District Chairperson and any designated official to expend and administer the budget**
16 **as attached, provided that any amendments affecting the funds or funding level shall**
17 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
19 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council**
21 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
22 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
