

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Assignment and Assumption of FY2011 Attorney Contract)**

RESOLUTION NO. 11-060

1 **WHEREAS, the Legislative Council, by Resolution No. 10-429, approved an Attorney Contract with**  
2 **Paul J. Matte III in the amount of \$35,000 for Fiscal Year 2011, for the period of October**  
3 **1, 2010 to September 30, 2011; and**

4 **WHEREAS, Paul J. Matte III intends to retire his legal practice prior to the expiration of the Fiscal**  
5 **Year 2011 Attorney Contract; and**

6 **WHEREAS, the Office of Attorney General continues to require the legal services of outside**  
7 **counsel to represent the Tohono O'odham Nation in legal proceedings in Maricopa**  
8 **County, Arizona, involving the Nation's interests under the Indian Child Welfare Act;**  
9 **and**

10 **WHEREAS, the Attorney General recommends that the Fiscal Year 2011 Attorney Contract with**  
11 **Paul J. Matte III be assigned to and assumed by Kerstin LeMaire; and**

12 **WHEREAS, the Domestic Affairs Committee has reviewed the Assignment and Assumption**  
13 **Agreement For Attorney Contract in FY2011 and recommends approval by the**  
14 **Legislative Council.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council approves the Assignment and**  
17 **Assumption Agreement For Attorney Contract in FY2011, substantially in the form**  
18 **attached hereto.**
- 19 **2. The Chairperson of the Nation is authorized and directed to execute the**  
20 **Assignment and Assumption Agreement.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
22 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council**  
24 **by Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
