

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval & Acceptance of the Natural Resource Damages Assessment Settlement Funds  
for the Tohono O'odham Nation Police Department a onetime payment of \$2,385.64)**

**RESOLUTION NO. 11-065**

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) received from the Cyprus**  
2 **Tohono Corporation part of the Natural Resource Damages Assessment Settlement**  
3 **Funds; and**

4 **WHEREAS, the TONPD has received a onetime payment of funds in the amount of \$2,385.64 for**  
5 **building improvement; and**

6 **WHEREAS, the TONPD has created a budget with line item 721 Supplies Other to purchase needed**  
7 **supplies for improving the TOPD North substation; and**

8 **WHEREAS, this budget will be effective until September 30, 2011.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
10 **approves and accepts the one time funding received from the Cyprus Tohono**  
11 **Corporation Natural Resource Damages Assessment Settlement Funds in the amount**  
12 **of \$2,385.64 for the Tohono O'odham Nation Police Department's North Substation for**  
13 **building improvement with a budget that has been created in the amount of \$2,385.64**  
14 **attached hereto.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**  
16 **Chairman and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
20 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and 174.50[05] ABSENT, pursuant to the powers vested in the Council**  
22 **by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
