

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amend Enrollment Resolution No. 07-706)

RESOLUTION NO. 11-077

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" (Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(b); and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance No. 05-81 (as amended) provides**
6 **that the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on November 5, 2007 the Legislative Council pursuant to Resolution No. 07-706,**
9 **approved Michael Anthony Maldonado III Roll No. 3431-CK-07 for membership in the**
10 **Tohono O'odham Nation; and**

11 **WHEREAS, on September 10, 2007 the Legislative Council pursuant to Resolution No. 07-546,**
12 **approved Esteban M. Molina-Norris Roll No. 3431-CK-06; and**

13 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
14 **and family tree, Michael Anthony Maldonado III listed with Roll No. 3431-CK-07 was**
15 **given the same number assigned to another member; Esteban M. Molina-Norris**
16 **pursuant to Resolution No. 07-546; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council approves a modification of Resolution**
23 **No. 07-706 as follows:**

24 **The Roll No. listed for Esteban M. Molina-Norris shall retain the Roll# 3431-CK-06**
25 **to reflect the number originally assigned to the application of Esteban M. Molina-**
26 **Norris September 10, 2007 which was approved by this Council pursuant to**
27 **Resolution No. 07-546. The Roll No. listed for Michael Anthony Maldonado III be**
28 **changed to 3437-CK-07.**

29 **2. The Enrollment Committee shall make the necessary changes in the records of the**
30 **Enrollment Office to incorporate the stated modification.**


