

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amend Enrollment Resolution No. 09-575)

RESOLUTION NO. 11-078

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" (Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(b); and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance No. 05-81 (as amended) provides**
6 **that the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on November 16, 2009 the Legislative Council pursuant to Resolution No. 09-575,**
9 **approved Precious M. P. Havier Roll No. 2639-SX-09 for membership in the Tohono**
10 **O'odham Nation; and**

11 **WHEREAS, on April 13, 2009 the Legislative Council pursuant to Resolution No. 09-167, approved**
12 **Ne'taliah L. Antone Roll No. 2639-SX-09; and**

13 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
14 **and family tree, Precious M. P. Havier listed with Roll No. 2639-SX-09 was given the**
15 **same number assigned to another member; Ne'taliah L. Antone pursuant to**
16 **Resolution No. 09-167; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council approves a modification of Resolution**
23 **No. 09-575 as follows:**

24 **The Roll No. listed for Ne'taliah L. Antone shall retain the Roll #2639-SX-09 to reflect**
25 **the number originally assigned to the application of Ne'taliah L. Antone April 13,**
26 **2009 which was approved by this Council pursuant to Resolution No. 09-167. The**
27 **Roll No. listed for Precious M. P. Havier be changed to 2665-SX-09.**

28 **2. The Enrollment Committee shall make the necessary changes in the records of the**
29 **Enrollment Office to incorporate the stated modification.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
