

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Appropriation for Budget Amendment No. 1 of \$250,424.00 to the FY 2011
Accounting Office Budget)

RESOLUTION NO. 11-087

1 **WHEREAS, the Tohono O'odham Nation Legislative Council approved the FY 2011 Accounting**
2 **Office Budget pursuant to Legislative Council Resolution No. 10-295; and**

3 **WHEREAS, the Office of the Chairman submits for review and approval FY 2011 Accounting Office**
4 **Budget Amendment No. 1; and**

5 **WHEREAS, the FY 2011 Accounting Office Budget is hereby amended increasing the budget by**
6 **\$250,424.00 to cover the cost to purchase two servers and Accounting Software for the**
7 **Tohono O'odham Nation Financial Management System; and**

8 **WHEREAS, FY 2011 Accounting Office Budget Amendment No.1 has been reviewed and approved**
9 **by the Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **appropriates \$250,424.00 from the General Surplus fund and approves the Accounting**
12 **Office Budget Amendment No. 1 attached hereto which authorizes a purchase of two**
13 **Servers and Accounting Software.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairperson and any designated official to expend and administer the budget as**
16 **attached, provided that any amendments affecting the funds or funding level shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
19 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
21 **VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
