1 **WHEREAS, at a regular scheduled meeting of the Tohono O'odham Legislative Council, held on**  
2 **March 2011 and;**

3 **WHEREAS, a budget amendment #1 for Choulic Community's FY 2011 budget was presented for**  
4 **review and approval; and**

5 **WHEREAS, the budget amendment #1 shall be as follows:**

10 **WHEREAS, this budget amendment will increase the Choulic Community's FY 2011 budget of**  
11 **\$170,592.28 by \$5,000.00 to a revised amount of \$175,592.28; and will also increase the**  
12 **overall District's FY 2011 budget of \$1,705,922.80 to an amended amount of**  
13 **\$1,710,922.80.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the budget**  
15 **amendment #1, in the amount of \$5,000.00 from gravel sales to the Tohono O'odham**  
16 **Nation Planning Department and incorporating it into the FY2011 Choulic Community**  
17 **budget.**

18 **BE IT FURTHER RESOLVED that this budget amendment does affect the original budget amount**  
19 **of \$170,592.28 for Choulic Community's FY 2011 budget to a revised amount of**  
20 **\$175,592.28; and will affect the overall FY 2011 District budget of \$1,705,922.80 to a**  
21 **revised amount of \$1,710,922.80.**

22 **BE IT FINALLY RESOLVED that any modifications, amendments, or changes in the justification**  
23 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**  
24 **O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
26 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**  
28 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
