

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Appropriation for Budget Amendment No. 1 of \$10,882.00 to the FY2011
Gaming Office Budget)

RESOLUTION NO. 11-101

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2011 Gaming Office Budget**
2 **pursuant to Legislative Council Resolution No. 10-295; and**

3 **WHEREAS, the Gaming Office submits for review and approval FY2011 Budget Amendment No. 1;**
4 **and**

5 **WHEREAS, the Gaming Office has discussed with the Executive Office and Commerce Committee**
6 **the need to create the Financial Analyst position; and**

7 **WHEREAS, the FY2011 Gaming Office Budget is hereby amended increasing the budget by**
8 **\$10,882.00 to cover the cost of personnel expenses and increasing the FY2011 budget**
9 **to \$4,617,571.58 from \$4,606,689.26; and**

10 **WHEREAS, the created Financial Analyst position is a recurring cost and will be added to the**
11 **Gaming Office annual budget; and**

12 **WHEREAS, FY2011 Gaming Office Budget Amendment No. 1 has been reviewed and approved by**
13 **Commerce Committee and the Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **appropriates \$10,822.00 from the General Surplus fund and approves the Gaming**
16 **Office Budget Amendment No. 1 attached hereto.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level shall be**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
22 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,160.70 FOR; 230.10**
23 **AGAINST; 204.70[03] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council**
24 **by Article VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by**
25 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
