

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and approving \$17,765.57 of carry forward funds from FY-2010 from the Bureau of Land Management for the Solid Waste Management Program FY 2011 BLM budget 11-1102)

RESOLUTION NO. 11-106

1 **WHEREAS, the Tohono O'odham Nation and the US Bureau of Land Management have entered**
2 **into a Cooperative Agreement #L08AC14165 to fund undocumented migrant trash**
3 **clean-up through December 30, 2012 as stated in the Cooperative Agreement; and**

4 **WHEREAS, this Cooperative Agreement amendment #2 to the contract provided an award of**
5 **\$75,000.00 to the Solid Waste Management Program to be expended by September 30,**
6 **2011 as so stated in approved Resolution 10-371; and**

7 **WHEREAS, an additional line item is created called other compensation 610.5 for needed**
8 **overtime to complete projects; and**

9 **WHEREAS, the Grants and Contracts Office has calculated an additional \$17,765.57 is available**
10 **as carry forward funds from FY-2010; and**

11 **WHEREAS, the Solid Waste Management Program FY2011 BLM Amended Budget 11-1102 has been**
12 **reviewed by the Legislative Natural Resources Committee and the Legislative Budget**
13 **and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
15 **approves the expenditure of \$17,765.57 of carry forward funds from the Bureau of**
16 **Land Management SWMP 11-1102 FY-2010 budget for the Solid Waste Management**
17 **Program FY 2011 11-1102 budget, to be expended by September 30, 2011 in accordance**
18 **with the budget attached hereto.**

19 **BE IT FURTHER RESOLVED that an additional line item is created called other compensation 610.5**
20 **for needed overtime to complete projects.**

21 **BE IT FINALLY RESOLVED by the Tohono Legislative Council that the Tohono O'odham Nation's**
22 **Officials, to wit: the Chairperson and any designated official are authorized to**
23 **negotiate and execute the agreement, provided however, that any amendments**
24 **affecting the funds or funding levels of the agreement shall be submitted for further**
25 **approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
27 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,493.14 FOR; 102.35**
28 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article**
29 **VI, Section 1 (d)(2) (3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
