

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2011 Budget Amendments for Florence Community
(Amendment #1) and the Gu Achi District Administration (Amendment #1))**

RESOLUTION NO. 11-107

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on March 23, 2011 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on February 26, 2011 at a regularly scheduled meeting, the Gu Achi District Council did**
4 **approved a budget amendment for Florence Community (Amendment #1, Resolution**
5 **#0211-417); and**

6 **WHEREAS, the Gu Achi District Council also approved Resolution #0211-415 "Approving the**
7 **proposal for five (5) Employees for the Gu Achi District Office for six (6) months"; and**

8 **WHEREAS, on March 11, 2011, the District Council also approved a budget amendment for the Gu**
9 **Achi District Administration (Amendment #1, Resolution #0311-428); and**

10 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
11 **the district's budget amendments for Florence Community and the District's**
12 **Administration submitted by the Gu Achi District and recommend for approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve the Fiscal Year 2011 Budget Amendments for Florence Community**
15 **(Amendment #1) and the Gu Achi District Administration (Amendment #1) with**
16 **attached documentation hereto.**

17 **BE IT FURTHER RESOLVED that the amendments do not affect the overall portion of the Gaming**
18 **Distribution of \$1,705,922.80 allocated to the Gu Achi District.**

19 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
20 **Year 2011 budget in accordance with protocols set forth by this Council. Any**
21 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**
22 **2011 budget shall be approved by the Tohono O'odham Legislative Council.**

23 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
25 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
