

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Carry Forward Budget for Child Care & Development Fund-Discretionary  
Funds from Grant Year 2010)**

**RESOLUTION NO. 11-111**

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood Development**  
2 **for its young members and providing for their welfare through various programs and**  
3 **services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**  
6 **Fund for Grant Year 2010 to implement Child Care Services through the Division of**  
7 **Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2010**  
9 **Carry Forward Discretionary Funds will be obligated by September 30, 2011 and**  
10 **liquidated by September 30, 2011; and**

11 **WHEREAS, the Division of Early Childhood Development has submitted for review and approval**  
12 **the proposed Carry Forward Budget for Child Care & Development Fund-Discretionary**  
13 **Funds from Grant Year 2010 totaling \$76,106.62; and**

14 **WHEREAS, the Grant Year 2010 CCDF Discretionary Carry Forward funds budget has been**  
15 **reviewed by the Human Resources Development Committee and the Budget and**  
16 **Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **approve the Carry Forward Budget for Child Care & Development Fund-Discretionary**  
19 **Funds from Grant Year 2010 for a total of \$76,106.62 for the following budget as**  
20 **attached hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Official, to wit: the Chairman and any designated official are authorized to**  
23 **negotiate and expend the budget, provided however, that any amendments affecting**  
24 **the funds or funding levels of the budget shall be submitted for further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
26 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
28 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**
