

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Healthy O'odham Promotion Program (HOPP) Budget Amendment #1
of Salary Savings from 10/01/10 – 02/28/11)

RESOLUTION NO. 11-112

1 WHEREAS, the Tohono O'odham Legislative Council approved the FY 2011 Healthy O'odham
2 Promotion Program, "(HOPP)" base budget of \$1,929,827.00 pursuant to Legislative
3 Council Resolution No. 10-314; and

4 WHEREAS, HOPP will be utilizing savings from line items 610-Salaries of vacant positions from
5 10/01/10 to 02/28/11 in the amount of \$59,436.75; 620-Fringe Benefits of \$19,316.94
6 and 771-Repair & Maintenance Equipment of \$2,300.00 for the first five months of the
7 fiscal year 2011; and

8 WHEREAS, the identified savings will make available to other line items to cover expenses for the
9 remainder of fiscal year 2011; and

10 WHEREAS, the Executive Office, the Health & Human Service oversight committee and the Budget
11 and Finance Committee has reviewed and approved this budget.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
13 and authorizes expenditures to the HOPP Budget Amendment No. 1 attached hereto.

14 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
15 Chairman and any designated official to expend and administer the budget, as
16 attached, provided that any amendments affecting the funds or funding level shall be
17 submitted for further prior approval by the Tohono O'odham Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH Day
19 of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
20 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article
21 VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the
22 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat. 984).
