

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving First Renewal of the Governmental Relations Representation
Contract with Triadvocates, LLC)

RESOLUTION NO. 11-117

1 **WHEREAS, the Legislative Council is vested with the authority to “consult, negotiate and conclude**
2 **agreements and contracts on behalf of the Tohono O’odham Nation with Federal, State**
3 **and local governments and other Indian tribes or their departments, agencies, or**
4 **political subdivisions, or with private persons or organizations on all matters within**
5 **the authority of the Tohono O’odham Council” (Tohono O’odham Constitution, Article**
6 **VI, Section 1(f)); and**

7 **WHEREAS, pursuant to Resolution No. 10-398, the Legislative Council approved a FY 2011**
8 **Governmental Relations Representation Contract with Triadvocates, LLC (“Contract”)**
9 **for the period commencing October 1, 2010 and ending March 31, 2011 for**
10 **governmental relations matters involving State of Arizona legislative, administrative,**
11 **appropriations, lobbying, and agency activities, as well as State of Arizona local and**
12 **municipal governmental activities that may affect the Nation; and**

13 **WHEREAS, the Contract expires on March 31, 2011 with an option to extend the term; and**

14 **WHEREAS, a “First Renewal of the Governmental Relations Representation Contract with**
15 **Triadvocates, LLC” (“First Renewal”) has been negotiated with Triadvocates which**
16 **would (1) extend the term of the Contract to September 30, 2011 and (2) increase**
17 **funding for the Contract by \$90,000 for a total of \$180,000; and**

18 **WHEREAS, the First Renewal has been reviewed by the Legislative Appropriations, Domestic**
19 **Affairs, and Budget and Finance Committees.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby:**

- 21 **1. Approves the First Renewal with Triadvocates, LLC in substantially the form**
22 **attached hereto which extends the term of the Contract from March 31, 2011 to**
23 **September 30, 2011 and increases funding for the Contract by \$90,000 for a total**
24 **of \$180,000; provided that the Contract shall be funded from the FY 2011 Executive**
25 **Branch Administrative Lobby Budget, Account No. 01-3002, 811-Lobby.**
- 26 **2. Authorizes the Chairman of the Nation to execute the First Renewal with**
27 **Triadvocates, LLC.**

28 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 24TH Day**
29 **of MARCH, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article**
31 **VI, Section 1 (f) of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**
32 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
