

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Planning and Economic Development Department's Budget Amendment #1
request to adjust the base budget amount for the FY 2011 budget of the
Credit & Finance Program)

RESOLUTION NO. 11-131

1 WHEREAS, the Credit and Finance Program under the Planning and Economic Development
2 Department is funded by BIA 638 Master Contract; and

3 WHEREAS, the Credit and Finance Program has been informed of the final FY 2010 distribution
4 base allocations; and

5 WHEREAS, the Planning and Economic Development Department provides oversight of the Credit
6 and Finance Program and is requesting Amendment #1 of the Credit and Finance
7 Program FY 2011 Budget approved by Resolution #10-296; and

8 WHEREAS, the Planning and Economic Development Department is requesting approval to adjust
9 the base budget amount from \$237,770.29 to \$247,703.00 and utilize the increase of
10 \$9,932.71 for operational purposes which includes adding new line items 723
11 Uniforms and 855 Consumables; and

12 WHEREAS, the Commerce and the Budget and Finance Committees have reviewed and approved
13 the Credit and Finance FY2011 Budget Amendment #1.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council hereby accepts
15 and approves the Credit and Finance FY2011 Budget Amendment #1 to correct the base
16 budget amount and increase the FY 2011 budget in the amount of \$9,932.71 to be used
17 for operational purposes; increases the budget from \$278,759.23 to \$289,102.11; and
18 increases Indirect Cost to \$41,399.11 in accordance with the budget attached hereto.

19 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20 Chairperson and any designated official to expend and administer the budget as
21 attached, provided that any amendments affecting the funds or funding level shall be
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day
24 of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,214.70 FOR; -0-
25 AGAINST; -0- NOT VOTING; and 380.80[06] ABSENT, pursuant to the powers vested in the Council
26 by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted
27 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
29 18, 1934 (48 Stat. 984).
