

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for FY 2011 expenditure of funds in the amount of \$58,721.78 from FY 2010 carry-forward funds for the Cultural Center/Museum Budget Account 44-1517, established for the expenditure of the 2009 Golf Contribution from the Desert Diamond Casinos)

RESOLUTION NO. 11-133

1 **WHEREAS, the Tohono O'odham Legislative Council approved the contribution from the Desert**
2 **Diamond Casinos that sponsored a golf tournament in March 2009 in the amount of**
3 **\$71,975.05 to benefit the Tohono O'odham Nation Cultural Center & Museum; and**

4 **WHEREAS, the FY 2011 carry-forward funds from the Desert Diamond Casino golf contribution be**
5 **expended in the amount of \$58,721.78; and**

6 **WHEREAS, the request to expend FY 2010 carry-forward funds from the Desert Diamond Casino**
7 **for the FY 2011 Cultural Center/Museum Budget 44-1517 has been reviewed by the**
8 **Legislative Cultural Preservation Committee and the Legislative Budget and Finance**
9 **Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the FY 2011 expenditure of FY 2010 carry-forward funds from the Desert Diamond**
12 **Casinos' 2009 golf contribution in the amount of \$58,721.78 in accordance with the**
13 **Cultural Center/Museum Budget Account 44-1517 attached hereto.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairman and any designated official to expend and administer the budget, as**
16 **attached, provided that any amendments affecting the funds or funding levels of the**
17 **budget shall be submitted for further prior approval by the Tohono O'odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
20 **of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and 174.50[05] ABSENT, pursuant to the powers vested in the Council by Article**
22 **VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**




