1 **WHEREAS, the Tohono O'odham Legislative Council approved the Water Resources Department**  
2 **FY11 budget 21-1525 through Resolution 10-306, in the amount of \$1,867,196.08; and**

3 **WHEREAS, the Water Resources Department is requesting that the line item 750 MAJOR CAPITAL**  
4 **be added to the FY11 budget 21-1525; and**

5 **WHEREAS, amendment 1 to the Water Resources Department FY11 budget 21-1525 has been**  
6 **reviewed by the Legislative Water Resources Committee and the Budget and Finance**  
7 **Committee.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **amendment 1 to the Water Resources Department FY11 budget 21-1525 to add the line**  
10 **item 750 MAJOR CAPITAL to the FY11 budget 21-1525, in accordance with the budget**  
11 **attached hereto.**

12 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
13 **the Chairperson and any designated official to expend and administer the budget, as**  
14 **attached, provided that any amendments affecting the funds or funding levels of the**  
15 **budget shall be submitted for further prior approval by the Tohono O'odham**  
16 **Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
18 **of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0- AGAINST;**  
19 **-0- NOT VOTING; and 174.50[04] ABSENT, pursuant to the powers vested in the Council by Article**  
20 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
