

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Office of Attorney General Budget No. 11-1524 for Bureau of Reclamation
Grant No. 04-NA-32-0100 for FY 2011)

RESOLUTION NO. 11-139

1 **WHEREAS, in September 2004 the Tohono O'odham Nation obtained a P.L. 93-638 grant from the**
2 **United States Bureau of Reclamation for \$270,700 to perform a study entitled**
3 **"Selection of the Preferred Irrigation Development Alternative for Selected Lands in**
4 **Sif Oidak District"; and**

5 **WHEREAS, this grant allows the Nation to further develop and settle the Nation's Sif Oidak water**
6 **claims by providing a plan to utilize the 8,000 acre-feet of CAP water made available**
7 **to the Nation in a 1980 contract with the Department of the Interior; and**

8 **WHEREAS, the Nation contracted with the Natural Resources Consulting Engineers, Inc., to**
9 **perform the study; and**

10 **WHEREAS, a cultural resources report for the lands under study has been recently completed by**
11 **the Nation, and NRCE is now prepared to finish the study; and**

12 **WHEREAS, the Office of Attorney General has prepared a budget for FY2011 for the remaining,**
13 **\$51,676.87 in the grant funds which are available to be expended to complete the**
14 **study; and**

15 **WHEREAS, the budget has been reviewed by the Domestic Affairs, Water Resources, and the**
16 **Budget & Finance Committees.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Budget**
18 **Number 11-1524 in the amount of \$51,676.87 for FY 2011 to expend grant funds from**
19 **the Bureau of Reclamation Grant No. 04-NA-32-0100.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
21 **Chairperson and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level shall be**
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
25 **of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
