

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing KOHN to expend for the Dedicated Revenue Account 01-3038 for Fiscal**  
**Year 2011)**

**RESOLUTION NO. 11-140**

1 **WHEREAS, KOHN is authorized by Resolution 09-554 to set up a Dedicated Revenue Account for**  
2 **the deposit of generated revenues including donations and contributions received;**  
3 **and**

4 **WHEREAS, all proceeds, net revenues, donations and contributions are restricted to Public**  
5 **Relations expenses including monetary donations given to individuals, groups and**  
6 **also payment of district profit share pursuant to an executed agreement; and**

7 **WHEREAS, KOHN has received underwriting Revenue in the amount of \$985.00 and has prepared**  
8 **the attached budget to authorize use of these revenues; and**

9 **WHEREAS, it is necessary for KOHN to request approval from the Tohono O'odham Legislative**  
10 **Council to expend the amount deposited into the Dedicated Revenue Account 01-3038**  
11 **for Public Relations purposes; and**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **and authorizes KOHN to expend the Dedicated Revenue Account 01-3038 for Public**  
14 **Relations expenses as provided in the attached budget, for the period of October 1,**  
15 **2010 - September 30, 2011.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budget as**  
18 **attached, provided that any amendments affecting the funds or funding level shall be**  
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
21 **of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,389.20 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 206.30[07] ABSENT, pursuant to the powers vested in the Council**  
23 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
24 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
