

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2011 Sells District-Ge Oidag Community Budget Amendment No.1)

RESOLUTION NO. 11-144

1 **WHEREAS, Sells District-Ge Oidag Community Resolution No. GO-81-2010; Sells District Council**
2 **Resolution No. SD-74-10; Legislative Council Resolution No. 10-387 approved the Sells**
3 **District-Ge Oidag Community Fiscal Year 2011 Budget and its justification; and**

4 **WHEREAS, the Ge Oidag Community identified the need to amend the FY2011 Budget to address**
5 **the needs of the community; and**

6 **WHEREAS, Ge Oidag Community has prepared and acquired approvals of the attached budget**
7 **Amendment and its Justification with Ge Oidag Community Resolution No. GO-64-11;**
8 **Sells District Council Resolution No. SD-22-11; and**

9 **WHEREAS, this Amendment will increase the amount of the line item for -710 Utilities; -727**
10 **Building Materials; -861 Miscellaneous Assistance; and**

11 **WHEREAS, the increase will reduce the budgeted amounts for Line Items -625 Scholarship; -724**
12 **Kitchen Supplies; -729 Animal Supplies; -750 Capital; -865 Emergency Assistance; and**

13 **WHEREAS, a new Line Item -711 Communication Expense will be added to the original budget;**
14 **and**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **Sells District-Ge Oidag Community Fiscal Year 2011 Budget Amendment No. 1 creating**
17 **a new line item -711 Communication Expense at an amount of \$3,000.00; increasing**
18 **line items -710 Utilities by \$5,000.00, -727 Building Materials by \$6,000.00, -861**
19 **Miscellaneous Assistance \$5,000.00; reducing Line Items -625 Scholarship & Tuition**
20 **by \$1,000.00, -724 Kitchen Supplies by \$1,000.00, -729 Animal Supplies by \$1,000.00, -**
21 **750 Capital by \$15,000.00, -865 Emergency Assistance by \$1,000.00.**

22 **BE IT FURTHER RESOLVED that this Amendment does not affect the overall approved Sells District**
23 **Fiscal Year 2011 Budgeted amount of \$1,705,922.80.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
25 **District Chairperson and any designated District Official to expend and administer the**
26 **budget, as attached, provided that any modifications or amendments affecting the**
27 **funds or funding levels of the budget shall be submitted for further prior approval by**
28 **the Tohono O'odham Legislative Council.**
