

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Gu-Vo District Administration Budget Amendment No.2, Gu-Vo Community
Amendment/Modification No. 1 and Ali Chngk Community Budget Amendment
No. 1 for FY' 11)

RESOLUTION NO. 11-149

1 **WHEREAS, the Gu-Vo District is requesting a modification to the FY' 11 Budget in order to conduct**
2 **business at their administration and communities levels; and**

3 **WHEREAS, the Administration of Gu-Vo District and communities did review the needs of the**
4 **Administration in amending, modifying and carrying over from fiscal years, to add**
5 **funds in the areas that have been depleted; and**

6 **WHEREAS, the Gu-Vo District Budget & Finance Committee did review and discuss the FY' 11**
7 **Budget expenditure report for the month of February and noticed that certain line**
8 **items were depleted and that additional funds are needed, and other needs the**
9 **administration and communities may have; and**

10 **WHEREAS, the Gu-Vo District Budget for Fiscal Year 2011 is in the amount of \$1,760,435.02; and**

11 **WHEREAS, the following have been amended for FY' 11:**

12 **1. Gu-Vo District Administration budget amendment no. 2 in the amount of**
13 **\$94,450.04 from Carry Over FY' 01 into FY' 11, increasing line items; 610, 612, 620,**
14 **655, 660, 712, 727, 771, and 850.**

15 **2. Gu-Vo Community budget amendment/modification no. 1 in the amount of**
16 **\$6,105.70, increasing line items 612 and 620, decreasing line items 624, 712, 774,**
17 **and 860.**

18 **3. Ali Chngk Community budget amendment no. 1 in the amount of \$67,200.00, from**
19 **Carry Over FY' 06, 07, 08, and 09 into FY' 11, increasing line items; 710, 711, 712, 750,**
20 **751, 771, 780, 854, and 866.**

21 **WHEREAS, the Gu-Vo District Budget for FY' 2011 has been increased in the amount of \$161,650.04**
22 **from FY' 01, 06, 07, 08 and 09 Carry Over; the grand total amount for Gu-Vo District FY'**
23 **2011 Budget is \$1,922,085.06; and**

24 **WHEREAS, Gu-Vo District Administration and communities did submit their budget Amendments**
25 **to the Tohono O'odham Legislative Council Budget & Finance Committee for review**
26 **and recommendations; and**

27 **WHEREAS, the Legislative Council Budget & Finance Committee does hereby recommends**
28 **approval to the Gu-Vo District Administration, Communities Budget FY' 11**
29 **Amendments, in addition, carry over.**

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves

the:

- 1. Gu-Vo District Administration budget amendment no. 2 in the amount of \$94,450.04 from Carry Over FY' 01 into FY' 11, Increasing line items; 610, 612, 620, 655, 660, 712, 727, 771, and 850.**
- 2. Gu-Vo Community budget amendment/modification no. 1 in the amount of \$6,105.70, increasing line items 612 and 620, decreasing line items 624, 712, 774, and 860.**
- 3. Ali Chugk Community budget amendment no. 1 in the amount of \$67,200.00, from Carry Over FY' 06, 07, 08, and 09 into FY' 11, increasing line items; 710, 711, 712, 750, 751, 771, 780, 854, and 866.**
- 4. The Gu-Vo District Budget for FY' 2011 has been increased in the amount of \$161,650.04 from FY' 01, 06, 07, 08 and 09 Carry Over; the grand total amount for Gu-Vo District FY' 2011 Budget is \$1,922,085.06.**

BE IT FURTHER RESOLVED that the Gu-Vo District's current budget for FY' 11 is in the amount of \$1,760,435.02, increased in the amount of \$161,650.04, with a total of \$1,922,085.06 for FY' 11.

BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its Fiscal Year 2011 budget according to the Tohono O'odham Nation's process but any amendments affecting the funds or funding levels shall be approved by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


