

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 10-399, "Approving San Lucy District FY 2011 Budget";
Approving San Lucy District - Administration Budget Amendment No. 1 and
San Lucy District - Administration Budget Amendment No. 2: Approving
San Lucy District - District Council Budget Amendment No. 1)**

RESOLUTION NO. 11-151

1 **WHEREAS, the Tohono O'odham Legislative Council on 8 October 2010 passed Resolution No. 10-**
2 **399 entitled, "Approving San Lucy District FY 2011 Budget" at a funding level of**
3 **\$2,655,644.38; and**

4 **WHEREAS, San Lucy District Council by resolution number SL 02-25-11 is requesting to bring**
5 **forward \$31,624.60 the balance of the FY 2010 San Lucy District Administrative Budget**
6 **line item 750 to the FY 2011 San Lucy District - Administrative Budget line item 750;**
7 **and**

8 **WHEREAS, San Lucy District Council by resolution number SL 02-26-11 is requesting to reallocate**
9 **\$23,130.64 from the San Lucy District's FY 2011 Administrative Budget line item 810 to**
10 **line item 610 and 620 to cover expends associated with two part-time workers;**
11 **reallocate \$18,583.00 from line item 861 to the San Lucy District Council's budget line**
12 **items 650 and 660 to cover over-expenditures and anticipate costs to end of the fiscal**
13 **year; and**

14 **WHEREAS, San Lucy District Council by resolution number SL 02-27-11 is requesting to reallocate**
15 **\$18,563.00 transferred from the district's Administrative Budget line item 861 to the**
16 **district council's budget line item 650 and 660 to cover over-expenditures and**
17 **anticipated cost associated with activities to end of fiscal year; and**

18 **WHEREAS, the Budget and Finance Committee have reviewed the budget amendment from the**
19 **San Lucy District Council and agreement to forward the request to the Tohono**
20 **O'odham Legislative Council for their consideration.**

21 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves San**
22 **Lucy District FY 2011 Administrative Budget Amendment No. 1 the carry-over of**
23 **\$31,624.60 from the FY 2010 San Lucy District Budget into the FY 2011 San Lucy District**
24 **Budget, and increases the San Lucy District FY 2011 Administrative Budget from**
25 **\$1,268,153.68 to \$1,299,778.28.**

26 **BE IT FURTHER RESOLVED the FY 2011 San Lucy District Budget is hereby increased from**
27 **\$2,655,644.38 to \$2,687,268.98.**

4 **\$18,583.00 from line item 861 to the San Lucy District Council's Budget.**

5 **BE IT FINALLY RESOLVED San Lucy District Council's Budget Amendment No. 1 is approved, funds**
6 **in the amount of \$18,583.00 is reallocated to line items 650 and 660 to cover over-**
7 **expenditures and anticipated costs to end of the fiscal year.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
9 **of APRIL, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
11 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
12 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
14 **Stat. 984).**
