 5 **WHEREAS, a budget amendment #1 for South Komelic Community and budget amendment #2 for**
 6 **Baboquivari District Administration was presented for review and approval; and**

10 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat. 984).
