

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Acceptance of the Arizona Department of Homeland Security, 2010 State Homeland Security Grant Award 777907-01 in the Amount of \$100,000.00)**

**RESOLUTION NO. 11-157**

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**  
2 **counties, through their respective states, to fund equipment purchases, personnel**  
3 **and training by departments that provide public safety services within their respective**  
4 **jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**  
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**  
8 **State of Arizona which was approved by Tohono O'odham Legislative Council through**  
9 **Resolution 09-256 for the purpose of obligating and distributing funds on a**  
10 **reimbursement basis to finance Homeland Security initiatives; and**

11 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the Arizona Department**  
12 **of Homeland Security in the amount of \$100,000.00 as part of the 2010 State Homeland**  
13 **Security Program Grant No. 777907-01 for the Homeland Security Initiative Planning**  
14 **Position for the Office of Emergency Management; and**

15 **WHEREAS, the 2010 State Homeland Security Program Grant No. 777907-01 award of \$100,000.00**  
16 **has been reviewed by the Office of Grants & Contracts, Executive Office, Domestic**  
17 **Affairs Committee and Budget & Finance Committee, of which all recommend**  
18 **acceptance of the grant award by the Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
20 **accepts the grant award of \$100,000.00 on a reimbursement basis from the Tohono**  
21 **O'odham Nation General Fund for the Homeland Security Initiative Planning position**  
22 **and further waives all indirect costs to administer this grant.**

23 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Office of Emergency Management is**  
24 **authorized to expend funds from this grant in the amount of \$100,000.00 in**  
25 **accordance with the terms of the 2010 State Homeland Security Program Grant No.**  
26 **777907-01 from October 1, 2010 to September 30, 2011.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation carries no obligation for funding or**  
28 **continued funding of this grant if the funding agency no longer obligates funds for the**  
29 **grant or if the agency or grant program becomes defunct for any reason.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
