

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Legislative Branch FY 2011 Budget Modification/Amendment No. 2)**

RESOLUTION NO. 11-168

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members "provided that" [a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Branch FY 2011 Budget Modification/Amendment No. 2 in the amount**
7 **of \$118,852.50 which provides for additional personnel and operational expenses and**
8 **does not change the approved FY 2011 Legislative Branch budget total amount of**
9 **\$3,269,563.62; and**

10 **WHEREAS, Legislative Branch FY 2011 Budget Modification/Amendment No. 2 would increase line**
11 **items 612-Occasional Appointment by \$7,000; 640-Committee Fee by \$6,000; 710-**
12 **Utilities by \$10,000; 711-Communication Expenses by \$30,000; 720- Supplies Office by**
13 **\$10,000; 721- Supplies Other by \$6,000; 771-RM Vehicles by \$5,000; 810-Professional**
14 **Services by \$7,000; 812-Public Relations by \$15,000; 850-Food by \$16,000 and 852-**
15 **Donation/Contributions by 6,082.50; and**

16 **WHEREAS, there are sufficient funds in the Legislative Branch FY 2011 budget to support the**
17 **proposed Legislative Branch FY 2011 Budget Modification/Amendment No. 2; and**

18 **WHEREAS, the Legislative Branch FY 2011 Budget Modification/Amendment No. 2 has been**
19 **reviewed by the Budget and Finance Committee.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
21 **approves Legislative Branch FY 2011 Budget Modification/Amendment No. 2 in the**
22 **amount of \$118,852.50 to increase line items; 612-Occasional Appointment by \$7,000;**
23 **640-Committee Fee by \$6,000; 710-Utilities by \$10,000; 711-Communication Expenses**
24 **by \$30,000; 720- Supplies Office by \$10,000; 721- Supplies Other by \$6,000; 771-RM**
25 **Vehicles by \$5,000; 810-Professional Services by \$7,000; 812-Public Relations by**
26 **\$15,000; 850-Food by \$16,000 and 852-Donation/Contributions by 6,082.50 and does**
27 **not change the approved FY 2011 Legislative Branch budget total amount of**
28 **\$3,269,563.62.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**
30 **Legislative Council Chairperson and Vice-Chairperson to administer the attached**
31 **budget, provided however, that any amendments that change the aggregate total of**
32 **funds originally budgeted or that change the purpose for which the funds were**
