

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment #1/Budget Modification #1 for Artesia-Little
Tucson FY 2011 Budget)**

RESOLUTION NO. 11-173

1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held in May**
2 **2011; and**

3 **WHEREAS, Baboquivari District Representatives brought forward a budget amendment #1/**
4 **budget modification #1 for Artesia-Little Tucson's FY 2011 budget; and**

5 **WHEREAS, the budget amendment #1 is to create a new Laborer position under the 610.32**
6 **Salaries line item; and**

7 **WHEREAS, the budget amendment #1 will utilize the savings from the vacancy of one home maker**
8 **position, to cover the salary for the new Laborer position for the remainder of the FY**
9 **2011 budget year; and**

10 **WHEREAS, the budget modification #1 will affect the line items listed below as follows;**

16 **WHEREAS, this amendment #1/modification #1 does not affect the original FY 2011 budget**
17 **amount of \$188,333.65 for Artesia-Little Tucson communities, nor will it affect the**
18 **overall Baboquivari District's FY 2011 budget of \$1,710,922.80; and**

19 **WHEREAS, after review and discussion, the budget amendment #1/modification #1 for Artesia-**
20 **Little Tucson's FY 2011 original budget was approved.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **budget amendment #1, which creates a new Laborer position and budget modification**
23 **#1 to decrease and increase the above mentioned line items.**

24 **BE IT FURTHER RESOLVED that this budget amendment #1/modification #1 will not affect the**
25 **Artesia-Little Tucson's FY 2011 original budget of \$188,333.65, nor will it affect the**
26 **overall Baboquivari District's FY 2011 current budget of \$1,710,922.80.**

27 **BE IT FINALLY RESOLVED any modifications, amendments, or changes in the justifications shall**
28 **be reviewed and approved by the Budget & Finance Committee and the Tohono**
29 **O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
31 **of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
32 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
33 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
34 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
35 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
36 **Stat. 984).**
