

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Xavier Allottees Association, Inc. Requests to Carryover the Remaining
Balance of \$5,879.08 in the Allottees SAWRSA Project Budget)

RESOLUTION NO. 11-174

1 WHEREAS, in 2002 and 2004, the Tohono O'odham Legislative Council (TOLC) approved funding
2 from the Tohono O'odham Nation's SAWRSA Trust Fund for the San Xavier Allottees
3 Association (SXAA) Allottee SAWRSA Project in the amount of \$110,060.00, Resolution
4 #02-114 in the amount of \$62,429.00 and Resolution #04-015 in the amount of
5 \$47,631.00; and

6 WHEREAS, in 2005, the TOLC approved the SXAA budget amendment to carryover the balance of
7 \$17,338.00 Resolution #05-691; and

8 WHEREAS, in 2010, the TOLC approved the SXAA budget amendment to carryover the balance of
9 \$13,820.21 in the Allottee SAWRSA Project by Resolution #10-214; and

10 WHEREAS, there is a continuing need to inform the allottees on the implementation of the 2004
11 SAWRSA Amendments (P.L. 108-451); and

12 WHEREAS, the SXAA Board has requested a budget amendment for the use of remaining balance
13 and has submitted a budget for postage, transportation and food for allottee meetings,
14 SXAA Res. #02-2011; and

15 WHEREAS, the TOLC Budget and Finance and the Water Resources Committees have reviewed this
16 budget amendment and are in support of the amendment.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council hereby approved
18 the San Xavier Allottees Association Board request to carryover the remaining balance
19 of \$5,879.08 for the Allottee SAWRSA Project per the attached FY 2011 Budget.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
21 of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
24 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).


