(Approving Amendment 1 to add Agricultural Extension Program FY2010 carry forward funds of \$40,080.01 and indirect cost charge (Contract Support) in the amount of \$6,168.86 to the FY2011 Program BIA Budget 10-1510, for a total budget of \$191,123.38)**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2011 Agricultural Extension**
2 **BIA Budget 10-1510 through Resolution 10-296, in the amount of \$144,874.51; and**

3 **WHEREAS, the Nation's Grants and Contracts Office has identified \$125,640.83 carry forward**
4 **funds from the FY2010 BIA funding; and**

5 **WHEREAS, the Agricultural Extension Program is requesting that the FY2010 carry forward funds**
6 **in the amount of \$40,080.01 and indirect cost charge (Contract Support) of \$6,168.86**
7 **for a total of \$46,248.87 be added to the FY2011 Agricultural Extension Program BIA**
8 **Budget 10-1510, for a total budget of \$191,123.38; and**

9 **WHEREAS, the remaining funds of \$85,560.82 from the \$125,640.83 be added to the Range**
10 **Conservation and Management Program FY2011 Budget; and**

11 **WHEREAS, the Agricultural Extension Program is also requesting that Line Item-650 Tuition and**
12 **Registration, 655 Lodging, 660 Travel Expense, 720 Supplies Office, 721 Supplies Other,**
13 **730 Dues and Subscriptions, 772 RM Building and Line Item 812 Public Relations be**
14 **added to the Agricultural Extension Program BIA Budget 10-1510; and**

15 **WHEREAS, Amendment 1 to the FY2011 Agricultural Extension Program BIA Budget 10-1510 has**
16 **been reviewed and recommends approval and adoption by the Legislative Agricultural**
17 **Committee and the Budget and Finance Committee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **Amendment 1 in accordance with the budget attached hereto:**

- 20 **1. To add FY2010 Bureau of Indian Affairs carry forward funds in the amount of**
21 **\$40,080.01 and indirect cost charge of \$6,168.86 (Contract Support) for a total of**
22 **\$46,248.87 be added to the FY2011 Agricultural Extension BIA Budget 10-1510, for**
23 **a total budget of \$191,123.38.**
 - 24 **2. To add Line Items 650 Tuition and Registration, 655 Lodging, 660 Travel Expense,**
25 **720 Supplies Office, 721 Supplies Other, 730 Dues and Subscriptions, 772 RM**
26 **Building and Line Item 812 Public Relations to the FY2011 Agricultural Extension**
27 **BIA Budget 10-1510. This increase would be a onetime increase to the FY 2011**
28 **Budget.**

9 **Section 1 (d)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**
