

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting May 25, 2011 Special Session for an Appropriations and Federal Lobbying Update)**

LEGISLATIVE ORDER NO. 11-184

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Appropriations Committee has requested a special session for May 25, 2011 at  
9 10:00 a.m. for an appropriations and federal lobbying update to the Legislative  
10 Council.

11 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a  
12 special session for May 25, 2011 at 10:00 a.m. for an appropriations and federal  
13 lobbying update.

14 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day of  
15 MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
16 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of  
17 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
18 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
19 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
