5 **Resolution #0411-465)and Cababi Community (Amendment #1, Resolution #0411-466),**

7 **WHEREAS, on April 29, 2011 at a regularly schedule meeting, the District Council also approved**
8 **budget amendments for the Gu Achi District Administration (Amendment #2,**
9 **Resolution #0411-479)and North Santa Rosa Community (Amendment #1, Resolution**
10 **#0411-480); and**

11 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
12 **the district's budget amendments for Covered Wells, Cababi, North Santa Rosa**
13 **Communities and the District Administration submitted by the Gu Achi District and**
14 **recommend for approval.**

BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal Year 2011 budget in accordance with protocols set forth by this Council. Any amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year 2011 budget shall be approved by the Tohono O'odham Legislative Council.

BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH Day of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
