

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2011 Wildland Fire Management Amendment No.1)

RESOLUTION NO. 11-201

1 **WHEREAS, the Tohono O'odham Nation/Department of Public Safety/Fire Department has taken**
2 **over Operations of the P.L. 93-638, Wildland Fire Management (Preparedness) from**
3 **the Bureau of Indian Affairs to operate the program indefinitely; and**

4 **WHEREAS, funding has been provided by BIA Wildland P.L. 93-638, for the operation of the**
5 **Wildland Fire Management (Preparedness); and will be utilized to provide emergency**
6 **services in saving of lives, property, and protect the natural resources and wildlife of**
7 **the Tohono O'odham Nation; and**

8 **WHEREAS, the Wildland Fire Management Division/Fire Department request approval to include**
9 **the FY 2010 carry forward funds of \$264,132.79 to the FY 2011 Budget; and**

10 **WHEREAS, the Wildland Fire Management has submitted FY 2011 Budget Amendment No. 1 to**
11 **increase from \$229,493.70 to \$530,861.55, which will include the carry forward funds**
12 **of \$264,132.79, and increase the IDC from \$33,330.70 to \$38,159.84; and**

13 **WHEREAS, the personnel chart corrects the title of the Battalion Chief Position to the Fire**
14 **Management Officer in FY 2011 Budget and adds a new Wildland Firefighter position.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2010 carry forward savings of \$264,132.79, and the FY 2011 IDC in the amount of**
17 **\$38,159.84 for a grand total amendment of \$302,292.63; approves the title change of**
18 **Battalion Chief to Fire Management Officer, and authorizes retroactive payment to the**
19 **Fire Management Officer from October 1, 2010, and authorizes expenditure in the**
20 **attached budget amendment no. 1.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget, as**
23 **attached, amendments affecting the funds or funding levels of the budget shall be**
24 **submitted for further prior approval by this Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH Day**
26 **of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
28 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
