

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Amendment #2 for Choulic Community's FY 2011 Budget)

RESOLUTION NO. 11-203

1 **WHEREAS, at a special session of the Tohono O'odham Legislative Council, held on May 2011; and**

2 **WHEREAS, Baboquivari District Representatives presented a budget amendment #2 for Choulic**
3 **Community's FY 2011 budget; and**

4 **WHEREAS, the amount of \$33,774.57 was identified as carryover dollars available from previous**
5 **years for the Choulic Community; and**

6 **WHEREAS, the budget amendment #2 would utilize a portion of the identified carryover dollars,**
7 **in the amount of \$10,000.00; and**

8 **WHEREAS, the amount of \$10,000.00 would be applied to the following personnel and operational**
9 **line items:**

17 **WHEREAS, the remaining amount of \$23,774.57 would be utilized at a later date; and**

18 **WHEREAS, this budget amendment #2 would increase Choulic Community's FY 2011 current**
19 **budget amount of \$175,592.28 to \$185,592.28 and would also increase the overall total**
20 **budget for the Baboquivari District's FY 2011 current budget amount of \$1,710,922.80**
21 **to \$1,720,922.80.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reviewed,**
23 **discussed and approved the Choulic Community's FY 2011 budget amendment #2, to**
24 **increase their personnel and operational line items identified above, by the amount**
25 **of \$10,000.00, from identified \$33,774.57 carryover dollars and that the remainder of**
26 **Choulic Community's carryover dollars, in the amount of \$23,774.57 will be utilized**
27 **at a later date.**

28 **BE IT FURTHER RESOLVED that this budget amendment #2 will increase Choulic Community's**
29 **current FY 2011 budget amount of \$175,592.28 to \$185,592.28 and also increases the**
30 **overall total budget for the Baboquivari District's FY 2011 current budget amount of**
31 **\$1,710,922.80 to \$1,720,922.80.**

32 **BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications**
33 **shall be reviewed and approved by the Budget and Finance Committee and the Tohono**
34 **O'odham Legislative Council.**


