

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Appropriation for Budget Amendment #1 of \$713,767.97 to the FY 2011**  
**Department of Information and Technology's Budget)**

RESOLUTION NO. 11-204

1 WHEREAS, the Tohono O'Odham Legislative Council approved the FY 2011 Department of  
2 Information and Technology Budget pursuant to Resolution No. 10-295; and

3 WHEREAS, the office of the Chairman submits for review and approval FY2011 Department of  
4 Information and Technology Budget Amendment No. 1; and

5 WHEREAS, the FY2011 Department of Information and Technology is hereby amended increasing  
6 the budget by \$713,767.97 as a onetime appropriation to cover the cost of Desktop  
7 upgrades and to purchase Servers upgrades for the Tohono O'odham Nation; and

8 WHEREAS, the Department of Information and Technology Amendment No. 1 has been reviewed  
9 and approved by the Budget and Finance Committee.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby  
11 appropriates \$713,767.97 from the surplus funds as a onetime appropriation and  
12 approves the Department of Information and Technology's Budget Amendment #1  
13 attached hereto adjusting the total budget of \$2,338,405.00 to \$3,052,172.97.

14 BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council hereby authorizes the  
15 Chairperson and any designated official to expend and administer the budget, as  
16 attached, provided that any amendments affecting the funds of funding levels of the  
17 budget shall be submitted for further prior approval by the Tohono O'Odham  
18 Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26<sup>TH</sup> Day  
20 of MAY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;  
21 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,  
22 Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
23 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
24 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
