4 **combined amount of \$210,283.00; and**

5 **WHEREAS, the Education Department – One Stop Division and the Grants & Contracts office has**
6 **identified a remaining balance in the amount of \$78,153.85 per attached financial**

8 **WHEREAS, the Tohono O'odham Legislative Council recognizes the seven (7) individual budgets**

26 **Nation's Officials, to wit; the Chairman and any official appointed designee is hereby**
27 **authorized to expend the budget provided however, that any amendment affecting the**
28 **funding or funding levels of this budget shall be submitted for further prior approval**
