

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Interim Directors Tohono O'odham Legislative Council Housing
Committee to the Tohono O'odham Ki:ki Association Board of Directors)

RESOLUTION NO. 11-212

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to enact**
2 **ordinances "to promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **(Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Legislative Council established the Tohono O'odham Ki:Ki Association ("TOKA") as**
6 **a separate tribal entity in accordance with Article VI of the Constitution of the Tohono**
7 **O'odham Nation and pursuant to Legislative Council Ordinance No. 98-03, as amended**
8 **("TOKA Ordinance"), 18 T.O.C. Ch. 1 (www.tolc-nsn.org/docs/Title18Ch1.pdf); and**

9 **WHEREAS, the TOKA Ordinance authorizes the Legislative Council to appoint five members to the**
10 **TOKA's Board of Directors and with the authority to "by resolution, suspend some or**
11 **all of the duties and responsibilities of a Director of the Board for a period not to**
12 **exceed six months." (TOKA Ordinance, Article V, Section 3); and**

13 **WHEREAS, the Legislative Council by Resolution No. 11-211 suspended the TOKA Board of**
14 **Directors; and**

15 **WHEREAS, it is in the Nation's best interest to appoint interim directors to serve on the TOKA**
16 **Board for a period not to exceed six months.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**
18 **an interim directors of the TOKA Board of Directors Tohono O'odham Legislative**
19 **Council Housing Committee, who is vested with all the duties and responsibilities of**
20 **a TOKA Board Director, provided that**

- 21 **1. The appointment made by this resolution shall be exempt from the requirements**
22 **of the Tohono O'odham Nation Board Appointment Guidelines.**
- 23 **2. The interim directors to the TOKA Board shall be eligible for election by the**
24 **interim TOKA Board of Directors to the office of interim chairperson, interim vice-**
25 **chairperson, or interim secretary.**
- 26 **3. The appointment made by this resolution shall expire six months from the**
27 **effective date of this resolution except as otherwise provided by subsequent action**
28 **of the Legislative Council, and provided that the appointment made by this**
29 **resolution shall immediately terminate if the interim director is no longer serving**
30 **on the Legislative Housing Committee.**
