

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Apportionment of District Votes on the Tohono O'odham Legislative Council)

LEGISLATIVE ORDER NO. 11-222

1 **WHEREAS, Article V, Section 2 of the Constitution of the Tohono O'odham Nation provides that**
2 **votes cast by Legislative Council representatives shall be apportioned as follows:**

3 **Each district shall be entitled to as many votes on the Tohono**
4 **O'odham Council (divided by ten) as there are members of the**
5 **Tohono O'odham Nation residing in the district. Such votes may be**
6 **cast by either or both of the district representatives, or their**
7 **alternates, who are present and voting.**

9 **WHEREAS, on Saturday, May 28, 2011 the Tohono O'odham Election Board conducted a general**
10 **election for the offices of chairperson of the Nation, vice-chairperson of the Nation,**
11 **and representatives and alternates to the Tohono O'odham Legislative Council and**
12 **district councils; and**

13 **WHEREAS, on the same date the Election Board issued and posted its Certificate of Election**
14 **Results in accordance with Section 6.K. of Article VII of the Uniform Election**
15 **Ordinance, Ordinance No. 03-86; and**

16 **WHEREAS, pursuant to Section 1.B. of Article VII of the Uniform Election Ordinance, the**
17 **Election Board certified and posted its Certification of District Residents, entitled**
18 **"Certification of District Votes," dated May 28, 2011, which is incorporated by this**
19 **reference, apportioning the number of votes each district is entitled to cast on the**
20 **Tohono O'odham Legislative Council; and**

21 **WHEREAS, the total number of Legislative Council votes apportioned and certified by the**
22 **Election Board in its "Certification of District Votes" totals 2,780.6; and**

23 **WHEREAS, the five-day period for appealing the number of votes apportioned to each district**
24 **by the Election Board has expired and no such appeal has been filed.**

25 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the**
26 **apportionment of votes each district is entitled to cast on the Tohono O'odham**
27 **Legislative Council shall be in accordance with the "Certification of District Votes"**
28 **totaling 2,780.6 and dated May 28, 2011.**

29 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 17TH day of**
30 **JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
31 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 2 of**
32 **Article V and Section 1 (g) of Article VI and Article X of the Constitution of the Tohono O'odham**
33 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
35 **of the Act of June 18, 1934 (48 Stat. 984).**
