

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Issuing Certificates of Election from the May 28, 2011 General Election for the Offices of
Chairman and Vice-Chairman of the Nation and Representatives and Alternates to the
Tohono O'odham Legislative Council and Seating Such Elected Officials)**

LEGISLATIVE ORDER NO. 11-223

1 **WHEREAS, on Saturday, May 28, 2011 the Tohono O'odham Election Board conducted a general**
2 **election for the offices of chairperson of the Nation, vice-chairperson of the Nation,**
3 **and representatives and alternates to the Tohono O'odham Legislative Council and**
4 **district councils; and**

5 **WHEREAS, the Election Board issued and posted its Certificate of Election Results dated May 28,**
6 **2011, which is incorporated by this reference, in accordance with Section 6.K. of Article**
7 **VII of the Uniform Election Ordinance, Ordinance No. 03-86; and**

8 **WHEREAS, Section 6.N. of Article VII of the Uniform Election Ordinance requires that the**
9 **Legislative Council issue Certificates of Election to the candidate who receives the**
10 **highest number of votes for chairman and vice-chairman of the Nation and for each**
11 **Legislative Council representative and alternate within 20 days after the Election**
12 **Board has posted its Certificates of Election Results; provided, however, that no**
13 **election contest is pending for those offices and further provided that a candidate**
14 **holding another elective public office of the Nation must resign before being seated;**
15 **and**

16 **WHEREAS, on May 31, 2011 statements were filed contesting the offices of Nation's chairman and**
17 **vice-chairman, Legislative Council representative and alternate for the Chukut Kuk**
18 **District, and other offices; and**

19 **WHEREAS, pursuant to Legislative Orders No. 11-213 through Legislative Order No. 11-221, the**
20 **Legislative Council conducted an election contest hearing on June 14-16, 2011 and**
21 **certified the elections for Nation's chairman and vice-chairman and Legislative**
22 **Council representative and alternate for the Chukut Kuk District.**

23 **NOW, THEREFORE, BE IT ORDERED that the chairperson and secretary of the Tohono O'odham**
24 **Legislative Council are hereby authorized and directed on behalf of the Council to**
25 **execute and deliver a certificate of election to each of the following persons elected as**
26 **chairman and vice-chairman of the Tohono O'odham Nation and as representatives**
27 **and alternates to the Tohono O'odham Legislative Council; provided that all such**
28 **persons shall hold office in accordance with the Uniform Election Ordinance, namely:**

29 **Chairperson of the Tohono O'odham Nation**

30 **Ned Norris, Jr.**

31 **Vice Chairperson of the Tohono O'odham Nation**
