(Certifying Elections of Council Representatives to the Legislative Council Standing
Committees and Seating Council Representatives to Committee Memberships)

LEGISLATIVE ORDER NO. 11-227

1 **WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to**
2 **“establish rules and procedures to regulate all meetings of the . . . standing**
3 **committees,” (Constitution, Article VI, Section 1(a)); and**

4 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council provide that “upon**
5 **the certification of elected officers, the Legislative Council shall, in alphabetical order**
6 **of the current legislative committees, proceed with the election of legislative**
7 **committee members” (Legislative Rules, Article XII, Section 3); and**

8 **WHEREAS, on June 17, 2011, following the election of Chairperson, Vice-Chairperson, and**
9 **selection of Secretary, the Tohono O'odham Legislative Council elected committee**
10 **members to the twelve standing committees by the process of retention, seniority, and**
11 **other means.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it certifies**
13 **the elections of legislative committee members and seats Council Representatives to**
14 **the following committee memberships:**


