

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying Elections of Committee Officers for the Legislative Council Standing Committees)**

LEGISLATIVE ORDER NO. 11-228

1 WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to  
2 "establish rules and procedures to regulate all meetings of the . . . standing  
3 committees," (Constitution, Article VI, Section 1(a)); and

4 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council provide that "upon  
5 the certification of elected officers, the Legislative Council shall, in alphabetical order  
6 of the current legislative committees, proceed with the election of legislative  
7 committee members" (Legislative Rules, Article XII, Section 3); and

8 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council provide that following  
9 the election of all legislative committee members, "the Legislative Chairperson, along  
10 with the Legislative Vice Chairperson, and the Legislative Secretary, shall call the  
11 respective legislative committees into committee caucuses to elect new officers."  
12 (Legislative Rules, Article XII, Section 3(J)(2)); and

13 WHEREAS, on June 17, 2011, following the election of Chairperson, Vice-Chairperson, and  
14 selection of Secretary, the Tohono O'odham Legislative Council elected committee  
15 members to the twelve standing committees by the process of retention, seniority, and  
16 other means; and

17 WHEREAS, following the election of all legislative committee members, the Legislative  
18 Chairperson, Vice Chairperson, and Legislative Secretary called the respective  
19 legislative committees into committee caucuses to elect new officers.

20 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it elects the  
21 following committee officers:


