

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #2 to the FY 2011 Budget 01-1020 to add the Position
of Purchasing Supervisor and to adjust other line items within
the Accounting Budget)**

RESOLUTION NO. 11-239

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2011 Accounting Budget 01-**
2 **1020, in the amount of \$2,994,903.85 with Resolution No. 10-295; and further increase**
3 **the Budget with Amendment #1 with Resolution No. 11-087 to \$3,245,327.85; and**

4 **WHEREAS, the Accounting Department is requesting the Tohono O'odham Legislative Council to**
5 **approve adding the position of Purchasing Supervisor and adjusting other line items**
6 **per the attached Budget; and**

7 **WHEREAS, the Accounting Department has assessed the needed change to Budget 01-1020 with**
8 **Amendment #2 and presented the amendment to the Budget and Finance Committee**
9 **for review.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **approves Amendment #2 to add the position of Purchasing Supervisor and adjusting**
12 **line items per the attached Budget, resulting in no increase or decrease to the current**
13 **FY 2011 Budget.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairperson and any designated official to expend and administer the budget, as**
16 **attached, provided that any amendments affecting the funds of funding levels of the**
17 **budget shall be submitted for further prior approval by the Tohono O'odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
20 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and 226.70[04] ABSENT, pursuant to the powers vested in the Council by Section**
22 **1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**


