

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Department of Health and Human Services, Division of Family Assistance –
FY2012 Low Income Home Energy Assistance Program – Budget, Account No. 12-1310)**

RESOLUTION NO. 11-241

1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial in**
2 **providing financial assistance to eligible low-income households in meeting utility**
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2012 through the State of Arizona,**
5 **Department of Economic Security, Division of Aging and Adult Services – Community**
6 **Action Program is \$62,572.00; and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the FY2012 budget for funding**
8 **through the State of Arizona, Department of Economic Security, Division of Aging and**
9 **Adult Services – Community Action Program in the amount of \$62,572.00 for contract**
10 **period July 01, 2011 through June 30, 2012; and**

11 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
12 **Division, Low Income Home Energy Assistance Program has submitted the FY2012 Low**
13 **Income Home Energy Assistance budget in the amount of \$62,572.00 for review and**
14 **approval; and**

15 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
16 **of the Legislative Council have reviewed this Budget and recommend its approval and**
17 **adoption.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **the FY 2012 Budget in the amount of \$62,572.00 and to utilize the Nations Resources**
20 **pending reimbursement from the Grantor for the continuation of the Contract.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget as**
23 **attached, provided that any amendments affecting the funds or funding level shall be**
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
26 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,544.80 FOR; 235.80**
27 **AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**






