

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2012 U.S. Department of Health and Human Services Centers
for Disease Control and Prevention (CDC) Comprehensive Cancer Control
Planning Grant Award, Account 11-1446)

RESOLUTION NO. 11-242

1 **WHEREAS, cancer is an increasing health risk for members of the Tohono O'odham Nation; and**

2 **WHEREAS, the Tohono O'odham Cancer Partnership has begun to implement the comprehensive**
3 **cancer prevention and control plan to address this health risk; and**

4 **WHEREAS, a five year grant was awarded to the Tohono O'odham Department of Health and**
5 **Human Services beginning June 30, 2007 – June 29, 2012; and**

6 **WHEREAS, this Budget represents the final year for the Comprehensive Cancer Control Grant;**
7 **and**

8 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
9 **of the Legislative Council have reviewed this Budget and recommend its approval and**
10 **adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
12 **authorizes expenditures in the following:**

- 13 **1. The U.S. Department of Health and Human Services, Centers for Disease Control**
14 **and Prevention (CDC) fifth year grant award of \$250,000.00 for budget period June**
15 **30, 2011 – June 29, 2012 with attached budget.**
- 16 **2. Should the Comprehensive Cancer Control Grant not receive further funding the**
17 **Tohono O'odham Nation will not be obligated to utilize the Nation's resources**
18 **beyond the final year.**

19 **BE IT FURTHER RESOLVED that the funds will be utilized by the Tohono O'odham Department of**
20 **Health and Human Services to implement the Tohono O'odham Nation**
21 **Comprehensive Cancer Prevention and Control Plan.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the Budget as**
24 **attached, provided that any Amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




