

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Department of Health and Human Services,
Division of Community Health Services, Public Health Preparedness and
Response - Bioterrorism (BT) FY 2012 Budget)

RESOLUTION NO. 11-243

1 **WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its**
2 **members who reside on or near the Tohono O'odham Nation Reservation, including**
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Response for Bioterrorism is within the charter of the**
5 **Tohono O'odham Department of Health and Human Services, Division of Community**
6 **Health Services; and**

7 **WHEREAS, the Tohono O'odham Nation entered into an Intergovernmental Agreement (IGA), with**
8 **the Arizona Department of Health Services (ADHS) for (Public Health) Preparedness**
9 **and Response for Bioterrorism on August 31, 2003; and**

10 **WHEREAS, Tohono O'odham Nation in Resolution No. 04-265 approved the IGA; and**

11 **WHEREAS, by Resolution No. 05-230 the IGA budget amendment No. 1 was approved and included**
12 **the provision to extend the IGA to August 30, 2008, and expanded the Scope of Work to**
13 **provide for Surveillance and Epidemiology focus areas; and**

14 **WHEREAS, Arizona Department of Health Services Fiscal Year 2012 Bioterrorism funding notice**
15 **was received and budget prepared in the amount of \$83,438.00; and**

16 **WHEREAS, by Resolution No. 09-123, a new IGA for the period August 9, 2008 through August 8,**
17 **2013 was approved by the Tohono O'odham Legislative Council; and**

18 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
19 **of the Legislative Council have reviewed this Budget and recommend its approval and**
20 **adoption.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 22 **1. Approves the 2012 BT budget in the amount of \$83,438.00.**
23 **2. To utilize the Nation's resources pending reimbursement from the Arizona**
24 **Department of Health Services for the continuation of the Agreement.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **Chairperson and any designated official to expend and administer the budget as**
27 **attached, provided that any amendments affecting the funds or funding level shall be**
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
