

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Intergovernmental Agreement with Arizona Department of Health Services Division of Community Health Services, Public Health Preparedness and Response Early Warning Infections Disease System (EWIDS) FY 2012 Budget)**

**RESOLUTION NO. 11-244**

1 **WHEREAS, the Tohono O'odham Nation is concerned with the Health, welfare and safety of its**  
2 **members who reside on or near the Tohono O'odham Nation Reservation, including**  
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Response for EWIDS is within the charter and**  
5 **mandate as provided by Resolution No. 07-100, affirming the Tohono O'odham**  
6 **Department of Health and Human Services, as the Nation's public Health authority;**  
7 **and**

8 **WHEREAS, the Tohono O'odham Nation did enter into an Intergovernmental Agreement (IGA),**  
9 **Contract No. HG954111, with the Arizona Department of Health Services (ADHS) for**  
10 **(Public Health) Emergency Preparedness and Response with a start date of August 9,**  
11 **2008 (terminating on 08/08/2013); and**

12 **WHEREAS, the Arizona Department of Health Services IGA, Contract No. HG954111, was approved**  
13 **by the Tohono O'odham Legislative Council by Resolution No. 09-123; and**

14 **WHEREAS, the Arizona Department of Health Services Fiscal Year 2012 EWIDS funding notice was**  
15 **received, and the attached budget prepared in the amount of \$38,911.00; and**

16 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
17 **of the Legislative Council have reviewed the budget and recommend its approval and**  
18 **adoption.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:**

- 20 **1. Approve the 2012 EWIDS budget in the amount of \$38,911.00.**  
21 **2. Utilize the Nation's Resources pending reimbursement from the Arizona**  
22 **Department of Health Services for the continuation of the agreement.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
28 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
30 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**






