

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services Division of Special Needs
FY 2012 First Things First Family Support/Child Development Budget)**

RESOLUTION NO. 11-246

1 **WHEREAS, the Tohono O'odham Nation has accepted and approved the Intergovernmental**
2 **Agreement (IGA) pursuant to Tohono O'odham Legislative Council Resolution 10-273;**
3 **and**

4 **WHEREAS, the Tohono O'odham Nation has consistently supported the development of its**
5 **youngest members by providing for their welfare through various programs and**
6 **services designed to meet their special needs; and**

7 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**
8 **budget as attached and incorporated by this reference, to be effective July 1, 2011**
9 **through June 30, 2012 and request authorization to expend funds First Things First**
10 **Family Support/Child Development Budget with IDC rate amount of \$ 13,385.64 for a**
11 **total budget of \$ 147,242.00.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **the First Things First Family Support/Child Development Budget for the Period July**
14 **1, 2011 through June 30, 2012.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
16 **Executive Branch to expend funds for the program listed above and as attached in the**
17 **amount indicated, effective July 1, 2011 through June 30, 2012.**

- 18 **1. Accepts the First Things First Family Support/Child Development Budget - with an**
19 **IDC rate Amount of \$ 13,385.64 for a total budget of \$ 147,242.00.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Official, to wit, the Chairman, Vice-Chairman and any designated official are**
22 **authorized to negotiate and execute the grant, provided however, that any**
23 **amendments affecting the funds or funding levels of the grant shall be submitted for**
24 **further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day**
26 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI,**
28 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**




