**RESOLUTION NO. 11-248**

- 1 **WHEREAS, the Tohono O'odham Nation through the Division of Early Childhood Development**  
2 **Special Services Program has successfully provided services and assistance to eligible**  
3 **Tohono O'odham children with disabilities and their families; and**
- 4 **WHEREAS, the Special Services Program through the Grants and Contracts Office has received the**  
5 **IDEA - B grant carry over allocation of \$61,459.66; and**
- 6 **WHEREAS, the carry over budget amendment #1 for account 11-1222 has an increase in line items**  
7 **650 Tuition and Registration; 655 Lodging; 660 Travel Expense; 700 Advertisement; 711**  
8 **Communication Expense; 720 Supplies-Office; 721 Supplies-Other; 722 Program**  
9 **Supplies; 810 Professional Services; 812 Public Relations; 850 Food; 856 Client Support;**  
10 **860 Special Activities; and**
- 11 **WHEREAS, the carry over budget amendment #1 for account 11-1222 establishes new line item 12**  
12 **Gas, Oil, and Coolants in the amount of \$3,000; 771 RM Vehicles in the amount of**  
13 **\$1,000; 867 Awards in the amount of \$1,200; and**
- 14 **WHEREAS, the carry over budget amendment #1 for account 11-1222 has a decrease in the**  
15 **Indirect Cost amount by \$3,634.93 changing it from the original amount of \$26,364.07**  
16 **to \$22,729.14; and increasing the budget from \$182,275.17 to \$247,369.76; and**
- 17 **WHEREAS, the Carry Forward Funds for Special Services Program account #11-1222 Amendment**  
18 **#1 has been reviewed by the Human Resources Development Committee and the**  
19 **Budget and Finance Committee.**
- 20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
21 **approve the Carry Over Funds Budget Amendment #1 in the amount of \$61,459.66 with**  
22 **an increase to the Indirect costs in the amount of \$3,634.93 changing it from the**  
23 **original amount of \$26,364.07 to \$22,729.14; and increasing the budget from**  
24 **\$182,275.17 for a new grand budget total of \$247,369.76 for Special Services Program**  
25 **account 11-1222 as attached here to.**
- 26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation's Official, to wit: the Chairman, Vice Chairman, and any designated official are**  
28 **authorized to negotiate and expend the budget, provided however, that any**
