

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2011 Budget Modification Amendment #1 for Head Start Grant
Account #11-1218)**

RESOLUTION NO. 11-249

1 **WHEREAS, the Tohono O'odham Nation through the Division of Early Childhood Development**
2 **Head Start Program has successfully provided services and assistance to eligible**
3 **Tohono O'odham children and their families; and**

4 **WHEREAS, the Head Start program, through the grants and contracts office has received Head**
5 **Start Program Grant account#11-1218 in the amount of \$1,524,913.00 direct costs and**
6 **\$148,854.00 indirect cost for a total of \$1,673,767.00; and**

7 **WHEREAS, the Head Start Grant amendment #1 for account 11-1218 has a decrease in line items**
8 **610 Salaries and line item 620 Fringe Benefits; and**

9 **WHEREAS, the Head Start Grant amendment #1 for account 11-1218 has an increase in line item**
10 **712 Gas, Oil, and Coolants; and**

11 **WHEREAS, the Head Start Grant amendment #1 has been reviewed by the Human Resources**
12 **Development Committee and the Budget and Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
14 **approve the Head Start Program Grant amendment #1 for the following budget as**
15 **attached hereto:**

16 **Head Start Grant - \$1,524,913.00 + \$148,854.00 = \$1,673,767.00**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
18 **Nation's Official, to wit: the Chairman, Vice Chairman, and any designated official are**
19 **authorized to negotiate and expend the budget, provided however, that any**
20 **amendments affecting the funds or funding levels of the budget shall be submitted for**
21 **further prior approval.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day**
23 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (d)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
