**RESOLUTION NO. 11-251**

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**  
2 **successfully providing services and assistance to eligible Tohono O'odham children**  
3 **and families; and**

4 **WHEREAS, the original FY11 Mandatory Funds Budget was based on the previous years budget,**  
5 **and this Modification/Amendment #2 reflects an increase to the total budget by**  
6 **\$19,656.00 from \$649,623.00 to \$669,279.00, as reflected in the FY2011 CCDF Final**  
7 **Tribal Allocation Based on Appropriation; and**

8 **WHEREAS, the FY11 CCDF Mandatory Funds, Budget Modification/Amendment #2, Account 11-**  
9 **1202 has been reviewed and approved by the Human Resources Development**  
10 **Committee and Budget and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
12 **approve the Child Care & Development Fund FY11 Mandatory Funds, Budget**  
13 **Modification/Amendment #2 Account 11-1202, which reflects an increase to the total**  
14 **budget by \$19,656.00 from \$649,623.00 to \$669,279.00, to reflect the FY2011 CCDF Final**  
15 **Tribal Allocation Based on Appropriation for Mandatory Funds in the amount of**  
16 **\$649,623.00.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit; the Chairperson and any designated official are authorized**  
19 **to negotiate and expend the budget, provided however, that any amendments**  
20 **affecting the funds or funding levels of the budget shall be submitted for further prior**  
21 **approval.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> Day**  
23 **of JUNE, 2011 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI,**  
25 **Section 1(d)(2)(3)&(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
