

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Department of Health and Human Services, Management of Health, Public Health Preparedness and Response – Bio Terrorism (BT) Grant Award HG058245 FY 2011 Budget in the amount of \$80,000.00)**

**RESOLUTION NO. 11-256**

1 **WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its**  
2 **Members who reside on or near the Tohono O'odham Nation Reservation, including**  
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Emergency Response for Bioterrorism is within the**  
5 **charter of the Tohono O'odham Nation Department of Health and Human Services,**  
6 **Management of Health; and**

7 **WHEREAS, the Tohono O'odham Nation entered into an Fixed Price Intergovernmental**  
8 **Agreement (IGA) #HG058245, with the Arizona Department of Health Services (ADHS)**  
9 **for Public Health Preparedness and Response for Bioterrorism in the amount of**  
10 **\$80,000.00 with a project period of 09/01/10 - 08/31/15, requiring a 10% match per**  
11 **Center for Disease Control award stipulations; and**

12 **WHEREAS, the Tohono O'odham Nation indirect cost rate is 16.82% and the Arizona Department**  
13 **of Health Services (ADHS) has recommended reducing the indirect cost rate to 6.82%**  
14 **to meet the Center for Disease Control required 10% match; and**

15 **WHEREAS, the budget has been reviewed by the Budget Office, Grants & Contract, Executive**  
16 **Office, Health Committee and Budget & Finance Committee of all which recommended**  
17 **for acceptance by the Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 19 **1. Approves the FY2011 Bio Terrorism budget in the amount of \$80,000.00 with a**  
20 **project period of 09/01/10 - 08/31/15.**
- 21 **2. Authorizes the Nation to obligate and expend funds upon approval of this**  
22 **resolution.**
- 23 **3. Authorizes the Nation to meet the match requirement by reducing the IDC to**  
24 **6.82%.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level shall be**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


