

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2011 Department of Health and Human Services Title IV-B,**  
**Subpart 2 Carryover Budget for Division of Child Welfare Services, Approving**  
**the 10% Indirect Cost Rate for Title IV-B Budget)**

**RESOLUTION NO. 11-258**

1 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**  
2 **of Child Welfare Services to intervene against child abuse and neglect and to promote**  
3 **safe and stable families; and**

4 **WHEREAS, the Title IV-B, Subpart 2 Budget is authorized for a two year expenditure period,**  
5 **beginning October 1, 2010 and ending September 30, 2011, funding only the two fiscal**  
6 **years of FY 2010 and FY 2011; and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved the Title IV-B, Subpart 2 Carryover**  
8 **Budget in the allocated amount with an Indirect Cost at 10% of \$1,362.00 for Title IV-B,**  
9 **Subpart 2 Budget, Account 11-1342; and**

10 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**  
11 **Families (ACF), has notified the Department that The Child and Family Services**  
12 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**  
13 **starting October 1, 2007 and the Department requests approval to submit this budget**  
14 **with the following restricted 10% amount for indirect costs as \$123.82 for a total**  
15 **budget amount of \$1,362.00 for Title IV-B, Subpart 2 Carryover Budget; Account 11-**  
16 **1342; and**

17 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
18 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
19 **adoption.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve**  
21 **the FY 2011 Department of Health and Human Services Title IV-B, Subpart 2 Carryover**  
22 **Budget with an indirect cost to reflect the restricted 10% indirect cost rate, in the**  
23 **amount of \$1,362.00.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's Legislative Council hereby authorizes**  
25 **the Chairperson and any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding level is**  
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




