

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2011 Department of Health & Human Services Title IVB
Subpart 1 budget 11-1344 Amendment #1 for Division of Child Welfare)

RESOLUTION NO. 11-259

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health & Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**
5 **safe and stable families; and**

6 **WHEREAS, Title IV B, Subpart 1 grants require a 25% match, which the Nation matches through**
7 **the P.L. 93-638 master contract, specifically the BIA Social Services budget for child**
8 **welfare services and the BIA ICWA budget for Family Preservation Program, as**
9 **authorized by both P.L. 93-638 and the Department of Health & Human Services; and**

10 **WHEREAS, these Title IV B budgets are authorized for only a two year expenditure period,**
11 **beginning October 1, 2010 and ending September 30, 2012, funding only the two fiscal**
12 **years of FY 2011 and FY 2012; and**

13 **WHEREAS, Title IV B, Subpart 1 Budget 11-1344 was estimated at \$123,079.00 and was awarded**
14 **\$127,518.00, the 660 Travel expense and 850 Food line items were increased; and**

15 **WHEREAS, the Department of Health & Human Services is in receipt of the Notice of Award as Title**
16 **IV-B Subpart 1 budget 11-1344 with 10% IDC @ \$11,138.00 for a total of \$127,518.00; and**

17 **WHEREAS, the Executive Office, the Health and Human Service Oversight Committee and the**
18 **Budget & Finance Committee has reviewed and approved this budget.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
20 **the Title IV-B, Subpart 1 Budget 11-1344 with an IDC @ 10%. Increasing the IDC from**
21 **\$10,279.91 to \$11,138.00 and increasing the budget from \$123,079.00 for a new total of**
22 **\$127,518.00.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget, as**
25 **attached, provided that any amendments affecting the funds or funding level shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**






